As per the calendar,, the YSR "SUNNA VADDI" payment to the Self Help Groups (SHGs) for the period from April 2020 to March 2021 will be released by the Hon'ble Chief Minister on 20<sup>th</sup> April 2021 in Urban SHGs and requested to take all preparatory measures and make necessary arrangements for grounding of YSR "SUNNA VADDI" launch program by the Hon'ble Chief Minister on 20<sup>th</sup> April 2021.

Hence all the Project Directors are instructed to take the following preparatory measures and activities at the time of launching the programme.

1. All the Project Directors shall verify all the details / validation/calculation check and then send Confirmation & Proceeding of the YSR "SunnaVaddi" amount downloaded in the portal and shared through e-mail on or before 05-04-2021.
2. All the Project Directors shall organize launching programme of YSR "SunnaVaddi" at District level under the Chairmanship of District Collector with Public Representatives including concerned District Ministers & MLAs and also at ULB level with ULB level Public Representatives & Municipal Commissioner duly following Covid-19 protocol and ensure wearing mask and maintain physical distance.

Hence, all the Project Directors are instructed to complete the activities related to disbursement of YSR "SunnaVaddi" on priority basis as per the below schedule of time line without fail.
